Weatherford College, established in 1869, is the oldest continuing two-year college west of the Mississippi River. Located in Weatherford, Texas, the college also has a branch campus in Wise County and education centers in Mineral Wells and Granbury. The college, a member of the Southern Association of Colleges and Schools, is a fully accredited two-year institution of higher education.

The college is governed by an eight-member board of trustees, seven of which are elected at large for a term of six years and one board member is appointed for a two year term. Members of the board of trustees names and terms are as follows:

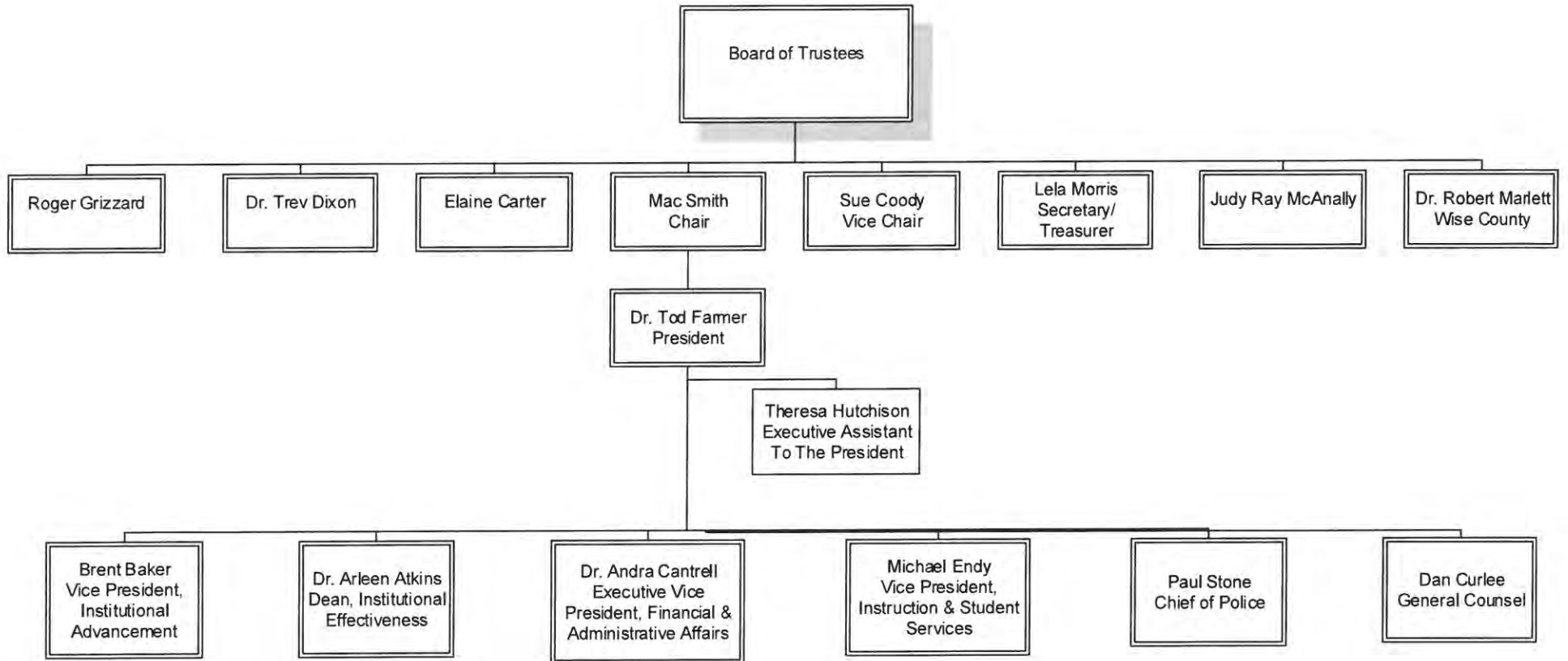
As one of the fastest growing counties in the state, Parker County and its surrounding area is faced with a population of students with very diversified needs. Without the requested funds from the State of Texas, many of these needs will be forced to go unaddressed as in prior years. Carryover issues for the previous biennium such as benefit funding issues with the TRS/ORP growth limitations have limited the college's ability to expand faculty and staff as needed.

Weatherford College is committed to student success in Texas in order to guarantee the future success of the state and its economy. With this strong commitment, the college has endured during challenging economic times. It is essential that the State of Texas provide sufficient base funding to provide educational services to the growing number of students in both academic and workforce training areas. We also ask that the Legislative Budget Board (LBB) consider revisiting the Weatherford College benefit funding TRS/ORP carryover issue from the previous biennium as discussed with LBB personnel. The opportunity to present the Weatherford College Legislative Appropriation Request for your consideration is greatly appreciated.

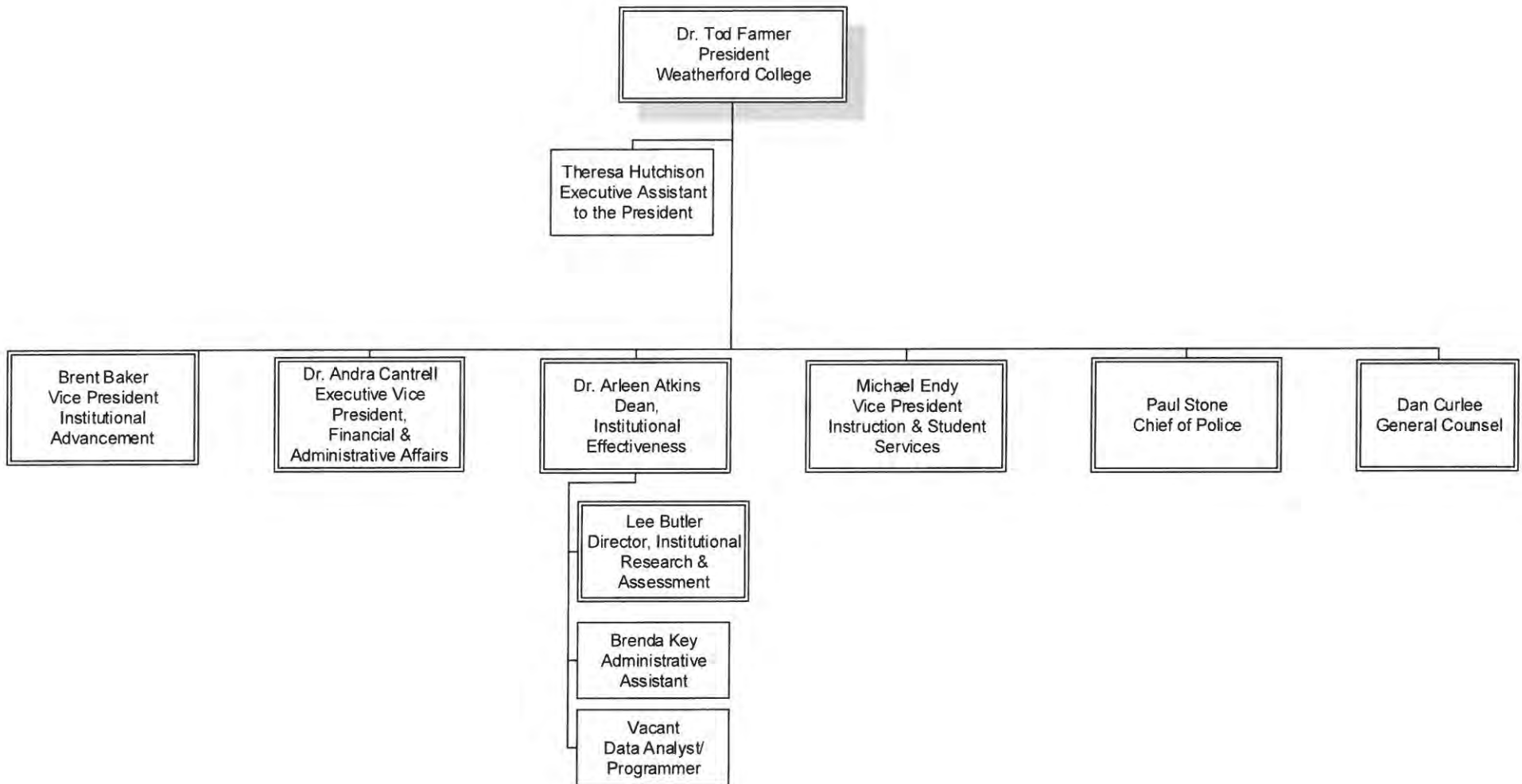
STATEMENT ON BACKGROUND CHECKS

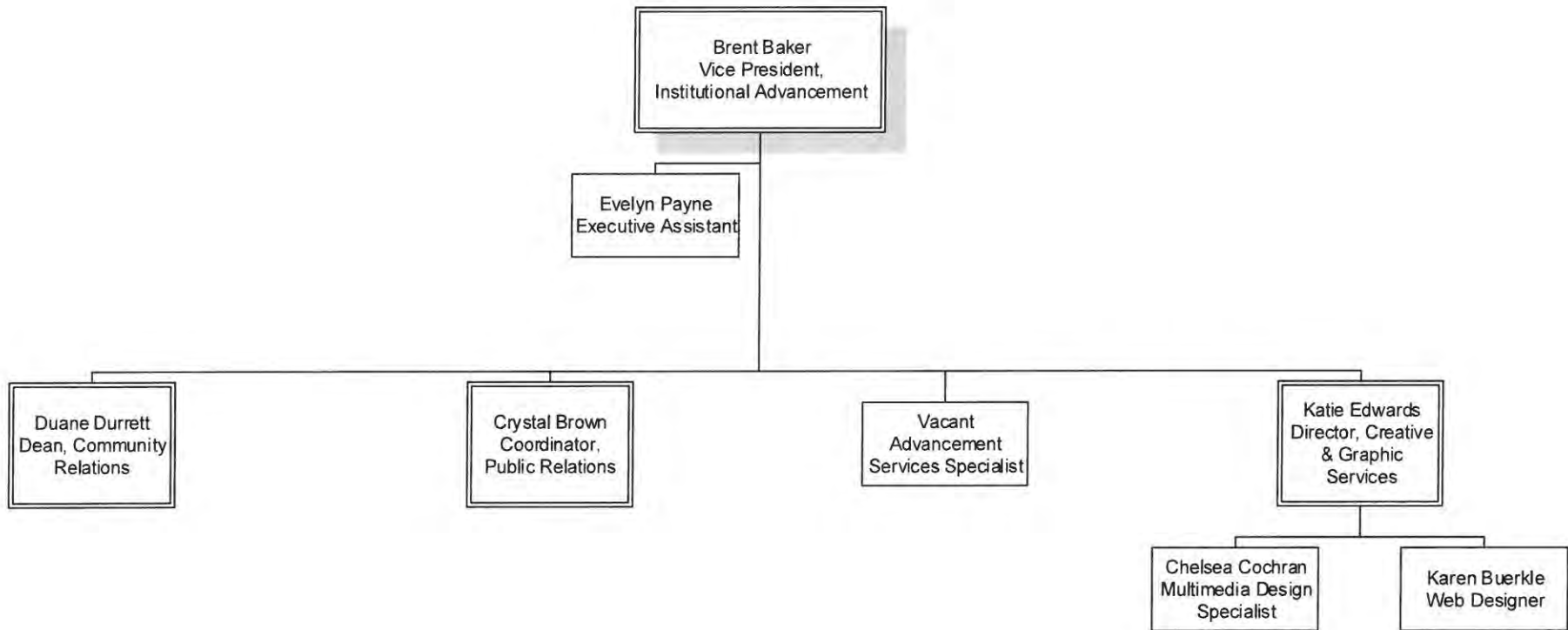
Weatherford College Governance and Administration 2017 – 2018



Weatherford College Office of the President 2017 – 2018



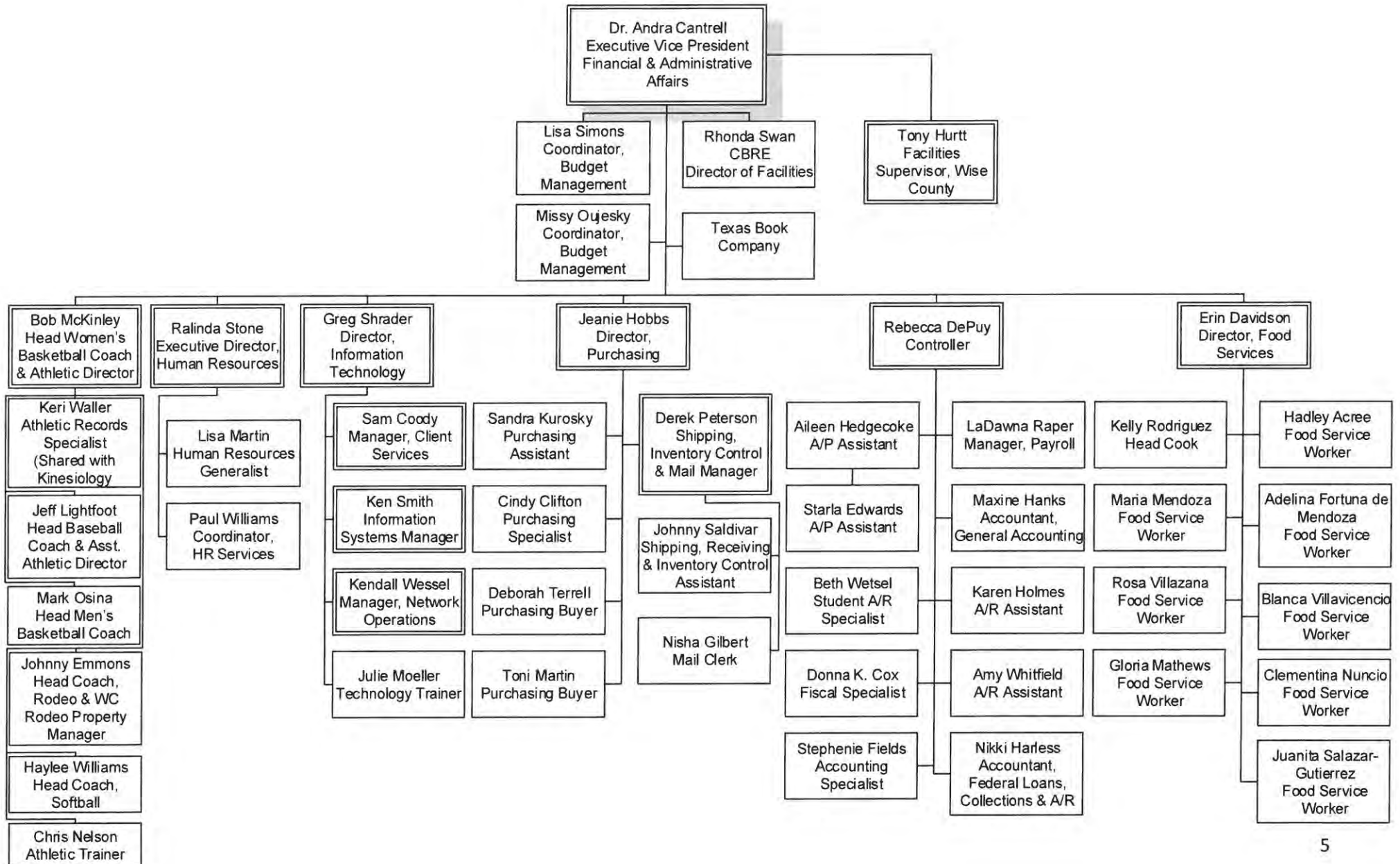
Weatherford College Institutional Advancement 2017 – 2018



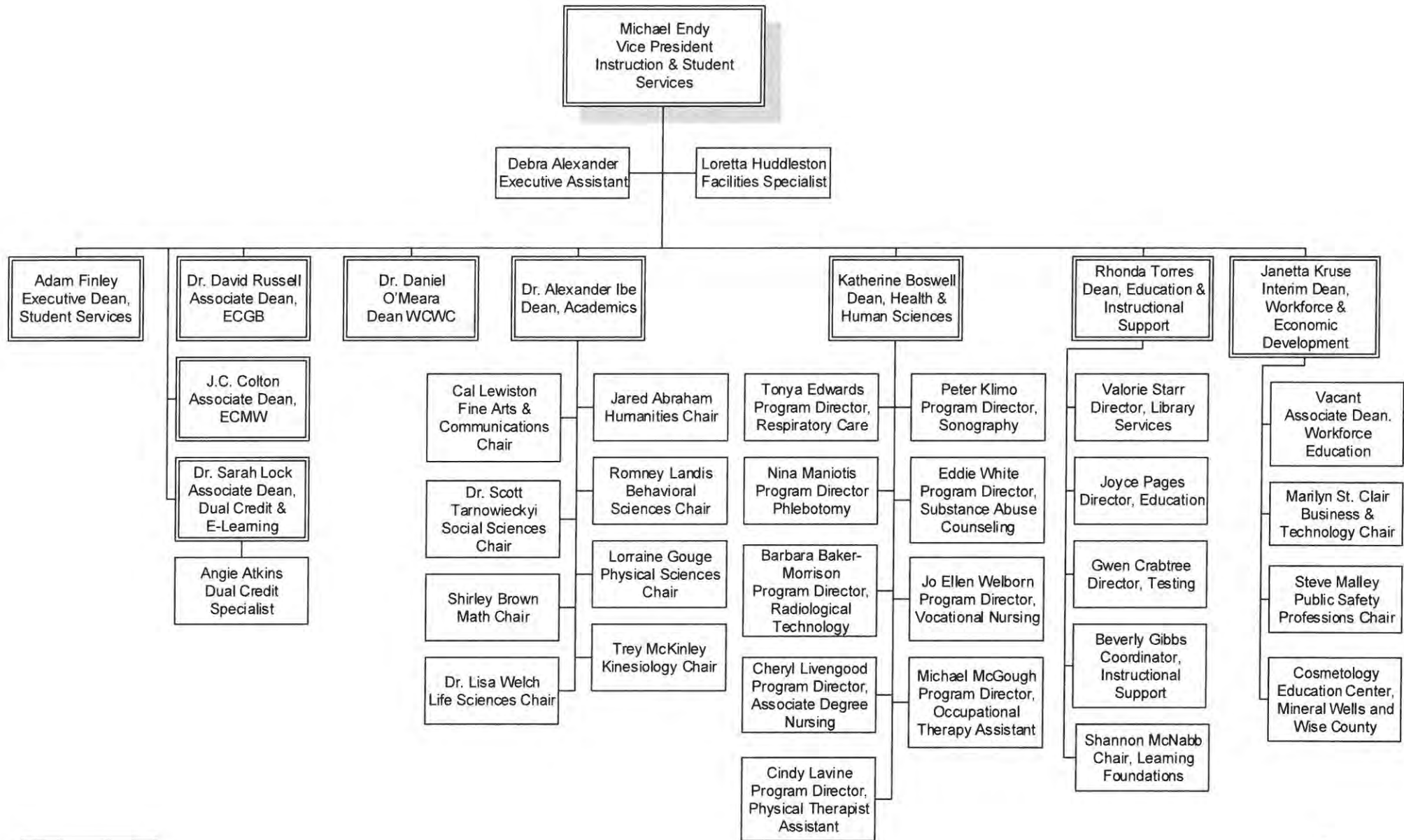

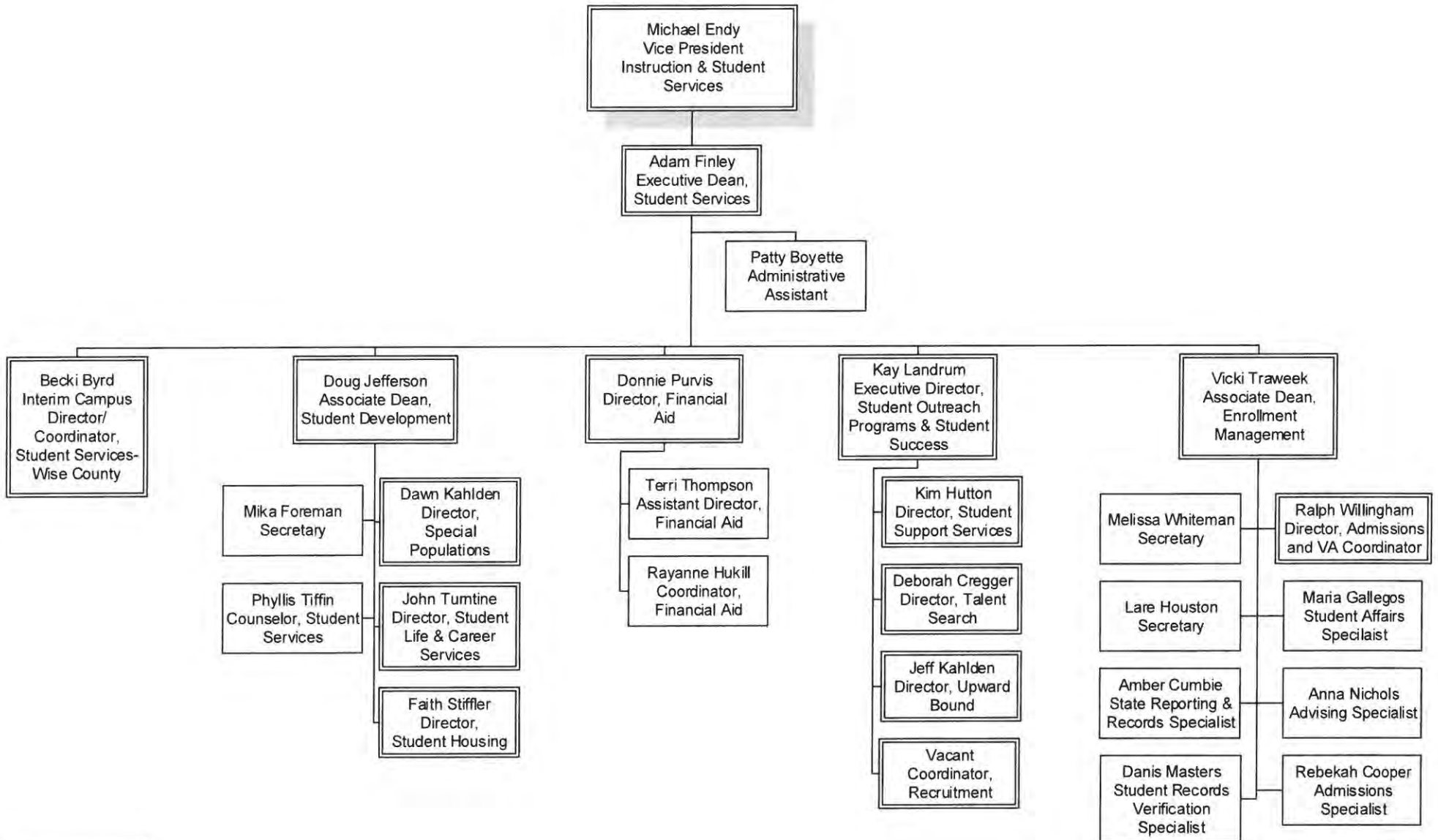
